Officers from State/ UT Government/ Public Sector Undertaking/ Autonomous Organization holding regular post in corresponding grades with requisite experience;

ii. Age below 56 years as on the closing date of the application.

Desirable Experience

- i. Experience in monitoring and implementation of large scale project(s) having multiple ecosystem partners.
- Experience in handling of matters relating to Budget, Contract management, Coordination, Administration, Procurement of goods and services etc.
- iii. Experience in e-Governance and ICT related projects.

Officers already holding analogous posts in the parent cadre/department may be given preference.

¹ There is no requirement for empanelment by the Central Government for holding the post of Jt. Secretary or equivalent for applying for above post.

3. Period and other terms and conditions of deputation:

- 3.1 The period of deputation shall be of five years. The lending department may relieve an officer for a lesser period as per their own policy/rules, which should not be less than three years in any case.
- 3.2 The general terms and conditions of services at UIDAI will be governed as per Unique Identification Authority of India (Appointment of Officers and employees) Regulations, 2020 and Unique Identification Authority of India (Salary, Allowances and other Terms & Conditions of Service of Employees) Regulations, 2020 and guidelines of the Central Government in this regard. - 3.3 The terms of deputation, including the pay and allowances, except leave shall be governed by the provisions laid down in the Department of Personnel & Training Office Memorandum No. 6/8/2009-Estt.(Pay II) dated 17 June 2010 and other orders/guidelines issued in this regard from time to time. Leave of an officer on deputation shall be regulated by leave rule of UIDAI.
- 3.4. Central Government Employee completing 05 years of service may also apply for above posts.
