#### 2. Period and other terms and conditions of deputation:

The initial period of deputation shall be for three years extendable by a further period of two years as per Department of Personnel & Training 0.M.No.6/8/2009- Estt. (Pay-II) dated 17.06.2010. The terms and conditions of deputation will be governed by the DoP&T's aforementioned O.M. of 17.6.2010 and Government of India's instructions issued from time to time on the subject.

- 3. Age Limit: The maximum age limit for appointment on deputation shall not exceed 56 years as on the closing date of receipt of application.
- 4. Eligibility for Government Accommodation: As per the ongoing arrangement the officers appointed in the UIDAI will be eligible for General Pool Residential Accommodation at par with Central Government employees.
- 5. Eligible and willing candidate may apply through proper channel in prescribed format: Annexure I.
