Unique Identification Authority of India (UIDAI), invites applications for filling up one post of Assistant Director General (ADG) (Finance & Accounts)(Director level) in the Pay Matrix Level 13 [pre-revised Pay Band IV (Rs. 37400-67000) plus Grade Pay of Rs. 8700/-] on deputation basis in its Headquarter in New Delhi, from amongst suitable and eligible officers. The eligibility criteria and qualifications for this post are as follows:

#### 1. Eligibility:

- i. Officers of Central Government/State Governments/UTs/PSUs/ Autonomous bodies holding analogous posts to that of Director's post in the Central Government Ministries/Departments;
- Officers belonging to Finance & Accounts Branch in various Ministries & Departments of Government of India, holding a post in the Pay Matrix Level 13 [pre-revised Grade Pay of 8700/-, as per 6<sup>th</sup> CPC];
- iii. Officers belonging to Accounts branch of Indian Army, Indian Navy and Indian Air Force, holding a post in the Pay Matrix Level 13 [pre-revised Grade Pay of 8700/-, as per 6<sup>th</sup> CPC];
- iv. Officers who may be at the end of their tenure under Central Staffing Scheme and may be interested in continuing on deputation under Non-Central Staffing Scheme (Director Level) subject to `No Objection Certificate' from DoP&T.

#### Desirable Experience:

The candidates should possess rich experience in the field of accounts, administration involving purchase procedure, tendering and contract finalization, budgeting, accrual accounting system and auditing of various functions such as purchases and finance, evaluation of internal controls etc in public sector and Government departments with exposure of audit of IT systems. Applicants holding corresponding positions possessing professional qualifications i.e. Chartered Accountant/ Cost and Works, Accountant/Subordinate Accounts Service (SAS), Accountant/ Master of Business Administration (MBA) (with finance specialization) with at least 10 years experiences in accounts work in a Central/State Government, Autonomous Body or Public Service Undertaking organization of which 5 years shall be in a senior position, will be given preference.

#### 2. Period and other terms and conditions of deputation:

The initial period of deputation shall be for three years extendable by a further period of two years as per Department of Personnel & Training O.M.No.6/8/2009-Estt. (Pay-II) dated 17.06.2010. The terms and conditions of deputation will be governed by the DoP&T's aforementioned O.M. of 17.06.2010 and Government of India's instructions issued from time to time on the subject.

#### 3. Age Limit

The maximum age limit for appointment on deputation shall be 56 years as on the closing date of the application.

### 4. Eligibility for Government Accommodation

The officers appointed in the UIDAI will be eligible for General Pool Residential Accommodation at par with Central Government employees.

- 5. Eligible and willing candidate may apply through proper channel in prescribed format Annexure I. Cadre authorities/Head of Departments are requested to forward applications of eligible and willing candidates whose services can be spared on deputation immediately on their selection. The applications of only such officers would be considered that are routed through proper channel and are accompanied by following documents:
