SANCTION ORDER

Sanction of the Competent Authority is hereby conveyed for incurring an expenditure of **Rs.39,24,31,500/- (Rupees Thirty Nine Crore Twenty Four Lac Thirty One Thousand Five Hundred only )** as financial assistance to Registrars towards successful generation of **9806712 Aadhaar** (25472 Aadhaar generated payable @Rs. 50/- in Phase-I and **9781240 Aadhaar** generated payable @Rs. 40/- in Phase-II) for the month of **Feb' 2013** as per details in **Annexure-'A'**. The month-wise reconciliation of Aadhaar generation based on enrolment data has been carried out by CIDR. Based on the reconciliation figure of Aadhaar generated for phase-I and during Phase-II, a sum of Rs. 91,710/- is deducted from Govt. of Madhya Pradesh as "excess" payment and Rs. 10/- as "due" payment to Punjab & Sindh Bank. The expenditure involved will be debited to the budget head of the UIDAI for the Financial year 2012-13 under the following heads:-
