Subject: - Notification for expansion/modification in the list of supporting documents accepted as Proof of Address (PoA) and Date of Birth (DoB).

As per Regulation 10(2) of the Aadhaar (Enrolment and Update) Regulations, 2016 the Authority may expand or modify the list of acceptable supporting document through circulars or notifications from time to time. "An indicative list of supporting document accepted for verification of identity, address and date of birth is prescribed in Schedule-II of the regulation." In view of the problems being faced by the residents due to non-availability of the requisite documents, the expansion/modifications in Proof of Address and Date of Birth documents as mentioned below are made w.e.f. 9th November, 2016.
