Unique Identification Authority of India invites online bids on behalf of Chief Executive Officer (CEO) for "Temporary illumination of UIDAI HQ Building, Bangla Sahib Road, New Delhi during Independence/Republic Day Celebrations/Other days of National Importance" through Central Public Procurement Portal (<https://eprocure.gov.in/eprocure/app>) on per event basis from eligible contractors having valid electrical licence from the approved Govt. Agency and work experience in the relevant field. The Bid is also available of official website of UIDAI (www.uidai.gov.in)

1. Scope of the work:

- 1.1. Providing temporary decorative illumination on hire basis on special occasions/events by providing & fixing decorative chain light/ batten/ PVC / cotton strips fitted with batten holder and 2.7/3 watt LED lamps color temperature 2700 K having average spacing of around 400 mm in between the lamps the arrangement is to be fixed on vertically/ horizontally as well as on different shaped architectural structure within the UIDAI HQ Complex as per the requirement including circuit wiring of suitable size from existing main panel board to sub panel board.
- 1.2. The system should be connected to earthing stud at main panel, including maintenance of the entire system of event by providing and fixing the following materials complete as required.
- 1.3. The Total 2.7/3 watt LED lamp [2700K, efficiency > 85%, B22 type surge protection >_3KV] at UIDAI HQ Building with tricolor scheme on building as per the requirement. (One Quantity/Unit = each length of 20 meters with above stated spacing & specifications)
- 1.4. Providing temporary LED flood light 60/80/100 watt with suitable Reflector/Mixer and necessary sub-main wiring & PVC insulated A1 Conductor cable of suitable size and necessary control switch gear including maintenance during the nights of special occasions/events within the UIDAI HQ Complex as per the requirement.
- 1.5. The contractor shall complete the work in all respect at least one day in advance (14th August, 25th Jan, 1st October, 20th June or any other day as per requirement) forenoon and final trial run shall be given/shown on the same day. Almost 3-5 Days temporary illumination per event and tentative 4-5 events or as per actual requirement according to Govt. of India directions from time to time may be required in a calendar year.
- 1.6. The contractor shall provide proper uniform spacing of lamps not more than 40 cms or as pointed out by the building in-charge.




2. Terms & Conditions:-

- 2.1. Intending bidders should have executed at least one similar work successfully in Central or State Government/Central or State Government Undertaking/Central or State Government Autonomous Body/Reputed Private Organizations and each of value not less than Rs. 1.0 Lakh during last 2 years ending May, 2019. The bidders should produce self attested proof/evidence such as Purchase Order/Work Order/Payment particulars/Satisfactory performance certificate issued from the competent authority.
- 2.2. The prospective bidders should have an establishment/Main Office/Branch Office in Delhi/NCR.
- 2.3. The work shall be carried out as per specifications of CPWD for Electrical works amended time to time, as per actual requirement at site and to the satisfaction of the official in Charge.
- 2.4. Initially, the work will be awarded for a period of Two Years (Financial Year 2019-2020 & 2020-21) and may be extended further for a period of one year (FY 2021-2022) depending upon the performance of the contractor and convenience of UIDAI @ the same terms & conditions.
- 2.5. The work will be awarded to the bidder quoting the overall lowest price. The work will be effective from the date of award of the contract subject to submission of Performance Bank Guarantee (PBG) to the tune of 5% of Annual Contractual value with validity of 60 days beyond the contractual period.
- 2.6. No Tools, Plant etc shall be issued by UIDAI HQ.
- 2.7. Independence/Republic Day Celebrations etc are very prestigious event of National importance as such all due care and instructions related to this work should be followed accordingly.
- 2.8. The bidders and their laborers should be aware about guidelines and norms regarding preservation of building. Any consequent loss done to the building shall be made good on the risk & cost of the Contractor.
- 2.9. The work is to be carried out at very sensitive & highly prestigious site. Hence, the quality of work done and competence of the staff deployed should be in accordance with the high status of the site.
- 2.10. The building is guarded by CISF security where entry passes are required to be issued. The contractor has to follow all the prevailing security practices while working in the premises. Nothing extra shall be paid on account of labor wastage, as the work will be done in secured area.
- 2.11. The contractor shall employ reliable person bearing good moral character responsible for the overall work/arrangement during the illumination time throughout the night.



- 2.12. The contractor shall make his own arrangement for the watch and ward of the lamps, wires fittings and switches etc. and no claim in respect of any loss or theft shall be entertained by UIDAI HQ.
- 2.13. The contractor will take power supply tapping from the existing panel of the Building and electricity will be supplied free of cost for the work.
- 2.14. The contractor at his own cost should make good the damage done to the building/electrical installations during execution & maintenance of the work.
- 2.15. All material should be in good condition, electrically, mechanically and apparently.
- 2.16. The contractor shall take all safety/precautionary measures like providing life safety belts, helmets, gloves, ropes, insulation etc. required for the deployed workers for execution of the work. In case of any accident happened during the execution of work, the contractor shall be fully responsible for the same and any payment/compensation to the concerned worker shall be made by the contractor. No claim in respect of any accident/loss of life etc. shall be entertained by UIDAI HQ. The Successful Contractor would be required to furnish an Undertaking with effect to above before execution of work.
- 2.17. The contractor shall not remove his installation till the final measurements are recorded. No extra payment shall be made for period beyond the date specified in the work order.
- 2.18. All bidders are requested to visit the UIDAI HQ site and assess the quantum of work required thereof.
- 2.19. The rates shall be quoted per event excluding GST which would be paid extra as per actual.
- 2.20. The duration and timing of lighting will be decided by officer/official -in-charge.
- 2.21. Complying with the legal rules and regulations of the State Government and Central Government governing the work order would be the sole responsibility of the contractor.
- 2.22. Make of LED Bulb and flood light should be of good quality and brand of repute.
- 2.23. The temporary wiring being carried out for the illumination of the building will not leave open/bare conductor and all joints will be made with requisite insulations, tapes etc.
- 2.24. The layout for laying Chain lighting and the positioning of flood lighting will be made in such a manner to bring out the contour of the building & shall be approved by the Section Officer (in-Charge).
- 2.25. All Transportation arrangement to be made & borne by contractor, UIDAI would not be accountable for any subsequent Traffic police violations, permission etc.
- 2.26. Adequate precautions should be taken by the Contractor during rainstorm, wind etc, ensuring there shall be no loss to life & property.



- 2.27. The various size of cables proposed to be used for the work shall be proper quality & of sufficient insulation value with adequate current carrying capacity in relation to the no. of bulbs/load used in the circuits so that the voltage drop at the farthest point does not exceed the standard value/norms.
- 2.28. The Bidder should have Valid Electrical License at the time of bid submission and during execution of the work.
- 2.29. Payment shall be made electronically after successful completion of work including clearance of site.
- 2.30. UIDAI HQ reserves the right to accept/reject any bids/all bids without assigning any reason.
- 2.31. The work/contract may be discontinued by giving 10 days prior notice, if the performance of contractor is not satisfactory.
- 2.32. Indexing of all the documents to be done in a chronological order ensuring that all requisite/related documents are attached.

3.0 Bid Submission:

- 3.1 The interest bidder/s shall upload their bids (complete in all respect) on <https://eprocure.gov.in/eprocure/app> in two packets i.e. Two bids (technical bid and financial bid) system.
- 3.2 The bid shall be submitted online in Packet-1 and Packet -2 detailed as under:-
- a. Packet 1:- (Technical Bid)**
- Tender Fee + EMD
 - Requisite Documents as per bid.
- b. Packet 2:- (Financial Bid)**
- Schedule of price bid in the form of BOQUIDAItli.xls
- 3.3 **Technical Bid:** The bidder/s irrespective of nature of content of the documents must number all the pages of the bid sequentially before uploading. All the scanned files/documents as mentioned should be in *.PDF format except for the BoQ which should be *.xls format.
- 3.4 **Financial Bid:** The Financial Proposal/Commercial bid format as mentioned in Annexure-B provided as BOQUIDAItli.xls along with this tender document at <https://eprocure.gov.in/eprocure/app>. Bidder/s are advised to download this BOQUIDAItli.xls, as it is, and quote their offer/rates in the permitted column and upload the same in the commercial bid. Bidder shall not tamper/modify downloaded price bid template in any manner. In case, if the same is found to be tempered/modified in any manner, tender shall be rejected summarily and EMD would be forfeited and bidder is liable to be banned from doing business with UIDAI.



- 3.5 The Bidder shall prepare the bid based on details provided in the Bid documents. Bidder shall meet all the requirements of the Bid document.
- 3.6 **Firm Prices:** Prices quoted must be firm and final and shall not be any upward modifications except statutory requirement. The Bidder/s shall indicate the prices in Annexure-B enclosed with the Bid in Indian Rupees (INR) only. The Commercial/Financial bid should clearly indicate the "Price" to be charged without any modification whatsoever and should include all applicable charges/Taxes currently in force for the activities to be executed except GST which would be paid extra as per actual.
- 3.7 The bidder shall be required to submit a sum of Rs. 10,000/- (Ten Thousand Only) as "Earnest Money Deposit" and Rs.100/- (One hundred only) as "Tender Fee" to be submitted in the form of DD/Pay Order/Bankers' cheque in favor of "UIDAI", Payable at New Delhi. Scanned copy of the original shall be uploaded. The Bids not accompanied with EMD/Tender Fee shall be summarily rejected.
- 3.8 The original instruments (Hard Copies) in respect of Tender Fee & Earnest Money Deposit (EMD) as applicable must be delivered to the address as mentioned in the bid on or before the end date/time of bid submission as mentioned in the bid. The Bids shall be rejected for non-submission of original payment instrument like DD, Banker's cheque, etc. as applicable against the submitted bid. The Demand Draft attached/submitted for tender fee shall be non-refundable.
- 3.9 Exemption regarding Tender Fee and EMD would be allowed as per Govt. norms viz. NSIC/MSME, etc. (enclose copy of exemption letter).
- 3.10 Bids shall remain valid for 60 days after the last date of bid submission mentioned in the bid. A bid valid for a shorter period may be rejected by the UIDAI because of non-responsive.
- 3.11 In exceptional circumstances, the UIDAI may ask the Bidder to extend the validity of the Bid and accordingly validity of "EMD" shall be extended, if required.
- 3.12 **EMD/Bid Security:** The EMD/Bid Security of unsuccessful bidders would be released within a week time after acceptance of the tender without interest. EMD of the successful Bidder's would be released within a week time after furnishing of the Performance Bank Guarantee (PBG) and signing of the Contract, without interest.
- 3.13 **Forfeit of EMD/Bid Security:** If the Bidder/s withdraws his/her bid during the bid validity period mentioned in the Bid or the successful Bidder fails to furnish performance security (PBG)/sign the Contract.
- 3.14 The Bidder/vendor should qualify the eligibility conditions, shall submit the authenticated documents duly signed and any additional documents, if required.
- 3.15 Submission of Bids will signify the acceptance of all terms and conditions of the contract as mentioned in the bid/Annexure(s).
- 3.16 The Bid Document is not transferable.

3.17 Bid Rejection:

- a. If the valid and Original instruments (EMD/Tender Fee) do not reach to Deputy Director (Admin), 4th Floor, "Aadhaar", UIDAI HQ Building, Bangla Sahib Road Gole Market New Delhi-110001 on or before the bid-opening schedule i.e. date & time.
- b. Tenders not accompanying required information and documents are liable to be rejected.
- c. In case, the Bidder has not met the eligibility criteria.
- d. Conditional offers, if any, will be summarily rejected
- e. Canvassing in any form.

4.0 Bid evaluation/Award of work:

- 4.1 The Bids will be opened as per schedule mentioned in the bid and after opening of the Technical bids online, its results of qualified bidders as well as opening of Price/financial Bid will be intimated online through CPP Portal.
- 4.2 Evaluation of the bid will be online and offline both, and comments of the offline committee will be uploaded as per the online process.
- 4.3 The lowest quoted price (L1) among the technically qualified bids on acceptance of UIDAI, will be awarded the work.
- 4.4 The successful bidder/vendor will have to deposit Security-cum-Performance Guarantees (PBGs) of 5% of the contract value with validity of 60 days beyond the contract period of two year in the form of Bank Draft/Pay Order /Banker's cheque from any Commercial Bank in favor of "UIDAI" payable at New Delhi.
- 4.5 The successful bidder has to submit his/her acceptance and PBG within 10 days on the receipt award letter. The successful bidder will sign a contract within a week time after verification of PBG from the respective Bank.
- 4.6 PBG is returnable on successful completion of the contract period without interest. The security amount will be forfeited in case the services of the contractor are found unsatisfactory or in case of violation of the terms and conditions of the contract.
- 4.7 UIDAI, Headquarter reserves the right to reject/any/all bid(s) without assigning any reasons whatsoever at any stage of tendering. Canvassing in any form will be considered as disqualification from award of contract.
- 4.8 UIDAI shall issue purchase order as per the requirement and supplier would supply within ten working days on receipt of the PO.



5.0 Payment Terms:

- 5.1 The UIDAI shall pay the agreed amount on production of original bills after satisfactory delivery of services. No other charges of any kind shall be payable.
- 5.2 No Payment shall be made in advance to neither the contractor nor any loan from any bank or financial institution is recommended based on work award.
- 5.3 Payment will be processed only after confirmation of PBG from the issuing bank.
- 5.4 All payment shall be made by ECS/e-payment only and UIDAI shall be at liberty to withhold any of the payment in full or in part subject to Penalty/Deduction as applicable.
- 5.5 Statutory deductions, TDS etc, as applicable shall be made at source from each running/final bill payment. A certificate of TDS shall be issued by UIDAI HQ to the contractor.

5.6 Penalty/Deductions:

- 5.6.1 The contractor shall have to replace damaged lamps/fixtures/LEDs/wires with least recovery time. A penalty @ Rs. 100/- Per day per lamp/LED/flood light etc shall be made from the Contractor's Bill in case any damaged item found un-replaced.
- 5.6.2 Store/Space will be made available to the contractor free of cost for keeping his material to be used on the work from the date of commencement of work & up-to completion of the work. After completion of temporary illumination/lighting work, contractor has to remove next day. In case of failure, penalty of Rs. 500/- per day would be applicable.

Whereas the UIDAI is desirous that certain Works should be executed, i.e. Temporary illumination of UIDAI HQ Building, Bangla Sahib Road, New Delhi during Independence/Republic Day Celebrations/Other days of National Importance or as per the requirement (UIDAI, HQ) as described on these bidding documents, hereinafter called "the Works" and has accepted a bid by the Contractor for the execution and completion of such works and the remedying of defects therein. NOW THIS AGREEMENT WITNESSETH as follows:

1. In this Agreement words and expression shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be deemed to form and be read / construed as part of this Agreement, viz:
 - Bid Information Sheet
 - Bid information and Instructions to Bidders
 - Bid Evaluation /Award of work
 - Term & Conditions of Contract
 - Formats for submission of Bid (Annexure-A to D)
3. In consideration of the payments to be made by the UIDAI to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the UIDAI to execute and complete the works w.e.f.** _____ to _____ and remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The UIDAI hereby covenants to pay the Contractor in consideration of the execution and completion of the works and the remedying of defects therein, the Contract Price of **Rs _____ stated in the letter of award subject to such additions thereto or deductions there from as may be made under the provisions of the Contract at the times and in the manner prescribed by the Contract.
5. Jurisdiction of Court: The Courts at Delhi/ New Delhi shall have the exclusive jurisdiction to try all disputes arising out this agreement between the parties.
