Notice Inviting Quotation (NIQ)

Name of work: Repainting of various pipe line and other structures at UIDAI Technology Centre, Bengaluru- reg

1. Sealed Quotations are here by invited from the Contractors having valid registration on the date of issue tender with CPWD/MES/P&T/Railways/State PWD/PSU/Municipal corporation specific experience in similar nature of work i.e. "Repainting Work."

2. The scope of work involves execution of following items. Contractors are requested to quote their rates in following format attached **Annexure-II**

3. The quotations shall be submitted in the office of Dy. Director (Admin) UIDAI Technology Centre, Bengaluru-560092. **on or before 3.00 PM on 11/12/2019 and shall be opened at 3.30 PM** on same day in presence of agencies present at the above time.

4. The completion time for the work shall be **02 (two)** weeks after award of work.

5. The firm should submit the following, sealed and signed Documents, in order to participate in Quotation, failing which the agency participation shall be summarily rejected.

(i) Qualifying requirements of Contractor / Firm:-The firm should posses following Qualification and relevant documents to be enclosed along with the quotation.

a) Agency Should Have Permanent Account Number (PAN)

b) Agency should have valid registration on the date of issue of tender with CPWD/MES/P&T/Railways/State PWD/PSU/Municipal corporations.

c) Should have satisfactorily completed (Phase/Part completion of the scope of work in a contract shall not be considered, however pre-determined phasing of the work will be accepted) three works, each of Rs. 65,000/- or two works, each of Rs. 1,00,000/- or one work of Rs. 1,30,000/- in single contract of similar nature.

Client certificate for experience should show the nature of work done, the value of work, date of start, date of completion as per agreement, actual date of completion and satisfactory completion of work. Firms showing work experience certificate from non-government/non-PSU organizations should submit copy of tax deduction at sources certificate in support of their claim for having experience of stipulated value of work.

d) Agency should possess GST Registration.

(ii) Undertaking regarding GST compliance duly sealed & Signed (Enclosed as Annexure-I)

(iii) The original / downloaded NIQ duly signed on each page shall have

c) EMD of Rs. 3,300/- (Three thousand three hundred only) in this for DD in favour of UIDAI, Technology Centre, payable at Bangalore, the EMD of unsuccessful bidder shall be returned of the placing work order on successful bidder.

6. GENERAL CONDITIONS

i) Price & Payments:

a) The price shall be FOR at UIDAI Technology centre, Bengaluru-560092, inclusive of GST. 90% payment shall be released on successful completion of the work after statutory deductions. The balance 10% will be released after 3 months of completion of work.

b) The successful bidder shall submit performance Bank guarantee @ 10% work order value which will be released after 3 month of completion of work.

ii) **DEFECTS LIABILITY PERIOD:-** Defect liability period shall be of 3 months from the certified date of completion.

iii) **Security norms/ Guidelines** The contractor has to follow the local security / safety rules and regulations and such instructions on restricted hours of work may be imposed on him by the department local authorities. While working in security restricted zones, no claim whatsoever on account of loss of labour / idle labour etc. shall be entertained. While working in electrical hazards area adequate precaution to be taken by contractor.

iv) **Completion period & LD clause:-** Period of completion of work is **2 weeks** which shall be reckoned from the **7 th day of placing the work order**. If you fail to complete the work within the stipulated period and no justifiable reasons are found for the delay, compensation for delay shall be levied at the rate of 1% of total value of work order value per week subject to a maximum of 10% of the bill amount.

v) **Engineer In Charge:** Technical Officer (Electrical), UIDAI, Technology Centre, Bengaluru shall be the Engineer In-Charge for this work.

vi) **DEVIATION:** The quantity shown in the schedule may vary during actual execution of work. You shall carry out the work as per actual site requirement whatever be the change from the scope of

the items at the same rate as quoted by you upto the maximum limit of 10% of the total value of amount quoted.

vii) VALIDITY: The quotation shall be valid for a period of 90 days from the date of opening of quotation

viii) REJECTION CLAUSE:

a) UIDAI reserves the right to reject any or all of the quotations without assigning any reason thereof and shall not be bound to accept the lowest quotation only.

b) UIDAI reserves the right to disallow issue of Quotation to the working agencies whose performance at ongoing project(s) is below par or unusually poor.

c) UIDAI is not responsible for any postal delay in receipt of the quotations.

ix) On completion of work, the same shall be jointly measured by the department and the contractor. Unused materials, debris etc. shall be removed by the contractor. The final bill shall be processed as follows:

a) Measurement book will be jointly signed by the Contractor and the Engineer-In -Charge.

b) Completion certificate will be issued by the Engineer In-Charge.

c) Other relevant documents viz: Invoices, Delivery Challan, Test Certificate, Technical specifications etc. as required.

x) Specifications of Materials/work:

a. The used paint shall be branded / colour as approved by Engineer-In -Charge.

b. The work shall be carried out as per general engineering practices, CPWD specifications/ manufacturer recommendations, relevant IS or any higher standard of practice as applicable to the work.
