NOTICE INVITING TENDER through e-Procurement

1. UIDAI invites online bids (Technical and Financial) from eligible bidders which are valid for a minimum period of 180 days from the last date of submission of bids for and on behalf of the UIDAI for “**Hiring of Data Centre Maintenance Agency for UIDAI Data Centers at Bengaluru & Manesar**”. The RFP and other documents were published on CPP portal on 17 Oct 2018.
2. Documents may be downloaded from CPP portal <https://eprocure.gov.in/eprocure/app>. The critical dates have revised as mentioned below:

A.	Bid Submission End Date and time	07th Jan 2018, 1800 Hrs
B.	Technical Bid Opening Date and time	10 th Jan 2018, 1500 Hrs
C.	Financial Bid Opening Date and time	Will be communicated later

3. Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>. Bidders are advised to follow the instructions provided in the ‘Instructions to the Bidders for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <https://eprocure.gov.in/eprocure/app>. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
4. Not more than one bid shall be submitted by one Bidder. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to bid for the same contract as separate competitors. A breach of this condition will render the bids of both parties liable to rejection.
5. Bidder who has downloaded the RFP from Central Public Procurement Portal (CPPP) <https://eprocure.gov.in/eprocure/app>, shall not tamper/modify the RFP form including

downloaded price bid template in any manner. In case if the same is found to be tempered /modified in any manner, Bid will be completely rejected and EMD would be forfeited and Bidder is liable to be debarred from doing business with UIDAI.

6. Based on queries received from prospective bidders, if required, UIDAI may amend the RFP/issue corrigendum. Bidders are advised to visit again UIDAI website <https://uidai.gov.in/uid-tender> and CPPP website <https://eprocure.gov.in/eprocure/app> at least one day prior to closing date of submission of RFP for any corrigendum / addendum/ amendment.
