Note: The above dimensions are tentative, actual dimension may be worked out by visiting the premise. The supplier shall ensure that New Batteries should be fitted in the existing battery racks, if not, battery racks shall be supplied free of cost against the old racks.

Terms and conditions for bidders

1. Bidders Eligibility:-

- 1.1 A bidder should be in a similar kind of business viz. Supply, installation, testing and commissioning of VRLA SMF batteries for UPS for at least last three consecutive financial years (2012-13, 2013-14 & 2014-15) and having annual average turnover of Min. Rs. 10.0 Lakh during the financial years in the books of accounts.
- 1.2 The bidder should have the experience of completion of similar work orders during last three financial years (min two work orders in each financial year) in any of the Govt/Semi Govt. Departments/Autonomous Institutions/ Universities/Public Sector Undertakings of the Government of India or Government of NCT of Delhi or any other State Government.

- 1.3 Bidder should not have been blacklisted by any Central/State Government or Central/State Govt. PSUs or any institution in India. An undertaking to this effect shall be submitted by the bidder.
- 2. A bidder shall submit the bid which satisfies each and every condition laid down in this tender, failing which, the bid shall be rejected summarily.
- 3. Each bidder shall submit only one bid either by self or as a partner in joint venture. If a bidder or if any of the partners in a joint venture in more than one bid, the bids are liable to be rejected.
- 4. The bidder shall bear all costs associated with the preparation and submission of the bids and UIDAI, HQ in no case shall be responsible or liable for those costs, regardless of the conduct or outcome of the tender process.
- 5. Bidders shall submit the following documents:
 - a. Bid Security (EMD) of Rs. 15,000/- (Rupees Fifteen thousand only) and Tender Fee of Rs. 100/-(Rupees One Hundred only) separately in the form of DD (Demand Draft) issued by any Nationalised bank in favour of "PAO, UIDAI" payable at Delhi.
 - b. Self-attested copy of the PAN card issued by the Income Tax Department with copy of Income Tax Return of the last three financial years (2012-13, 2013-14 and 2014-15).
 - c. Self attested copy of Service Tax Registration No. /VAT No.
 - d. Self declaration that firm is Not blacklisted by any Government agency/PSU during past three years.
 - e. Self attested copy/proof of owning a registered office in NCT of Delhi.
 - f. Self attested copy/proof towards an authorized distributor/dealer or OEM supplier.
 - g. Annual Turnover (Min 10 Lakh) for Financial Years 2012–13, 2013–14 and 2014 15 supported by audited balance sheet.
 - h. Certificate/undertaking in respect of brand complying/conform to the specifications as per the requirement of UIDAI, Headquarter.
- 6. The last date of submission of bids will be on 29.03.2016 at 3.00 PM and the bid will be opened on the same day at 4.00 PM. Interested bidder or their representatives may remain present, if desire so. The bid security of the unsuccessful bidder shall be returned after finalization of the contract.
- 7. The Validity of bids shall be 60 days from the date of opening of bids.
- 8. Any tender not accompanied by Bid Security shall be rejected.
- 9. Conditional bids will also be summarily rejected.
- 10. One set of the technical literature/leaflet for the batteries quoted should be enclosed along with the bid. Offers without the necessary literature/leaflet for evaluation shall be rejected with sole responsibility of the bidder.

- 11. Bid Security shall be forfeited if the bidder withdraws his bid during the period of tender validity.
- 12. All rates shall be quoted separately for each battery size inclusive of all taxes & duties at unit cost basis.
- 13. The prices shall be quoted with the provision of buy back of the existing faulty batteries. So the net price of a battery will be worked out as quoted Price for new battery quoted Price for old battery (buy back). However, both prices will be quoted separately. A survey can be made by the bidders for quoting the price for buy back of old batteries, if required. The old batteries under "Buy Back" will be handed over to the successful firm on the installation, testing and commissioning of new batteries. The old batteries shall be removed immediately after commissioning of new batteries, in case of non-compliance caluse-29 shall be applicable.
- 14. The bidder shall submit the bid signed on each page along with requisite documents as specified in the tender including "EMD & Tender Fee" in a sealed envelope superscribed "Supply of Batteries under Buy-Back option in UIDAI HQ" and shall be dropped in the "Tender Box" available at 2nd Floor, Tower-I, Jeevan Bharati Building, Connaught Circus, New Delhi-110001. Bids submitted late shall not be entertained.
- 15. Financial evaluation of only those bidders shall be entertained who qualify the eligibility criteria to the satisfaction of UIDAI, HQ in the presence of bidders if they wish to be present.
- 16. The contract will be awarded to the firm/agency quoting lowest net price (Quoted Price of new battery "X" Quoted Price of old battery "Y" under "Buy Back"). "X" & "Y" may be seen under techno-commercial bid at Sr.no. 14 & 15 respectively.
- 17. A sum of 10% of the total order values will be kept as performance guarantee. The successful bidder shall be required to furnish the performance bank guarantee from any Nationalised Bank/ Cash/Demand Draft to Deputy Director (Admin) within seven days of the receipt of the offer. The performance guarantee shall be returned after 30 days of completion of the guarantee period without any interest.
- 18. The contractor shall arrange for the insurance covering the risk during transit. All the charges for such insurance shall be borne by the contractor
- 19. The batteries will be supplied within a period of 10 days after acceptance of the work order.
- 20. The supplier will install, test and commission all the batteries on site within a period of 5 working days after receiving the batteries.
- 21. Bid Security shall be forfeited if the successful bidder refuses or neglects to execute the contract within the time frame.
- 22. Payment shall be made after successful installation, testing, commissioning and removal of old batteries.

23. The order will be placed for 64 Nos. of 12V, 26 AH and 32 Nos. of 12V, 100 AH batteries. However, UIDAI HQ has the right to increase or decrease the number of batteries depending upon the actual requirement within a period of one year from the date of work awarded.

24. The batteries should be on-site guaranteed for minimum three years of trouble free operation from the date of commissioning. Any failure within three years after the delivery of equipment should be replenished free of cost.

25. The successful bidder has to supply two sets of printed user manual along with as erected drawing, along with the battery bank. No extra payment shall be made for documentation

26. Any other information/details may be had from the Deputy Director (Admin), 2nd Floor, Tower-I, Jeevan Bharati Building, Connaught Circus, New Delhi-110001, Contact no. 011-23466842 on any working day between 10:00 A.M. to 5:00 P.M. Interested parties may, if they so desire, visit the site personally on all working days.

27. The competent authority of UIDAI headquarter reserves the right to reject any bid without assigning any reason.

28. Handling charges and transportation expanses to take out the old batteries will be on account of the successful bidder.

29. **PENALTY FOR DELAY**: If the contractor is unable to complete the supply within the stipulated time limit the purchaser may at his option allow such additional time as may be considered justified with/without penalty and without altering terms and conditions of the order. In the event of failure of the contractor to complete the supply within the stipulated time or the extended time, the purchaser has the right to impose penalty of Rs.350/- per week or part thereof for every Rs.1,00,000/- of the contract price. The Contractor's liability for delay, however, shall not exceed 10% of the total contract price.

30. Violation of any terms & condition during warrantee period may invite forfeiture of performance of Bank Guarantee.

31. All the disputes are within the jurisdiction of Delhi.
