UIDAI acting through CEO, UIDAI invites online proposals (Pre-Qualification, Technical) from eligible bidders which are valid for a minimum period of 180 days from the date of opening (i.e., 15/11/2017) for “Request for Empanelment of Software Development Agencies”

E.	Bid Submission Start Date	1 st November 2017 at 1000 hrs
F.	Bid Submission End Date	14 th November 2017 at 1100 hrs
G.	Technical Bid Opening Date	15 th November 2017 at 1600 hrs

2. Bids shall be submitted online only at CPPP website: <https://eprocure.gov.in/eprocure/app>. Bidders are advised to follow the instructions provided in the ‘Instructions to the Bidders for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <https://eprocure.gov.in/eprocure/app> . Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
3. Not more than one bid shall be submitted by one Bidder. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to bid for the same contract as separate competitors. A breach of this condition will render the bids of both parties liable to rejection.
4. Bidder who has downloaded the RFE from the UIDAI website <http://uidai.gov.in/uid-tender> and Central Public Procurement Portal (CPPP) website <https://eprocure.gov.in/eprocure/app>, shall not tamper/modify the RFE form including downloaded price bid template in any manner. In case if the same is found to be tempered /modified in any manner, Bid will be completely rejected and Bidder is liable to be banned from doing business with UIDAI.

5. Based on queries received from prospective bidders, if required, UIDAI may amend the RFE/issue corrigendum. Bidders are advised to visit again UIDAI website <https://uidai.gov.in/uid-tender> and CPPP website <https://eprocure.gov.in/eprocure/app> at least 3 days prior to closing date of submission of RFE for any corrigendum / addendum/ amendment.
