

- (i) The handset shall have minimum one year warranty.
- (ii) Handsets shall be delivered within 05(five) working days from the date of placing order.
- (iii) No advance payment will be made. The successful bidder shall be released payment through ECS on raising Invoice alongwith Bank details.
- (iv) It shall be sole responsibility of the successful bidder to supply genuine handset and as per the specification available in the mobile handset of aforesaid make/Model.
- (v) The Bidders shall have valid PAN/TAN Number.
- (vi) The number of Mobile Handsets mentioned in this Tender Enquiry is tentative which shall be decided at the time of placing supply order.




4. **Technical Details:**

(a) Specifications of the Items to be included in the Supply Order are given in **Appendix-'A'** to this enquiry. The items offered by the bidders shall conform to these specifications failing which such tenders will be technically rejected.

5. **Eligibility Criteria:** The firm fulfilling the following eligibility criterions will considered for opening of their Financial-Bids:-

- (a) The bidder may be an Indian firm, a partnership firm or a proprietary firm with 2 years experience. The requisite deed of formation/association/registration etc. should be submitted in support to establish legal entity/credentials of the bidders.
- (b) Average annual financial turnover during the last two years, ending 31st Mar of the previous financial year from the date of opening of bid, should not be less than **Rs. 10 Lakhs**. Documentary evidence to this effect duly attested should be submitted alongwith the technical bid.
- (c) Bidder must have valid VAT / Sales Tax Registration Certificate. A copy of the certificate alongwith receipt of the last premium paid should be enclosed with the Technical-Bid.
- (d) Bidder must possess valid PAN Card. A copy of the same should be enclosed with the Technical-Bid.
- (e) Compliance to the Schedule of Requirement.
